Government Affairs Update from Keith Yoshizuka:

Although not exclusive to the Diablo chapter, I feel that this is important enough for our members to know. Effective October 2019, the federal form DEA-222 will no longer be a triplicate form; it is being replaced by a single page form with each party expected to make their own photocopies.

Existing triplicate forms will be phased out over a two year period. CSOS will continue to operate as the electronic DEA form for electronic transmission.
