1. <u>Call to order</u> at 6:45 p.m. by President-elect Jared Garcia in lieu of president Amy Le. A quorum was present.

- 2. Old Business.
 - A. The May 2021 Board Meeting minutes were approved by voice vote.
- 3. New Business.
 - A. The Board welcomes Touro Student Chapter President Darlene Nguyen to the meeting.
 - B. California Pharmacist Licensing Examination by Keith Yoshizuka.
 - There was much discussion regarding the California Practice Standards and Jurisprudence Examination (CPJE) vs. the Multistate Pharmacy Jurisprudence Examination (MPJE). The Deans of the California Schools of Pharmacy (California Pharmacy Council) have proposed the California Board of Pharmacy change from the CPJE to the MPJE licensing examination. Currently, an applicant must pass both the CPJE and NAPLEX (North American Pharmacist Licensure Examination) as part of the qualifications to be a licensed pharmacist.
 - 2. The CPJE consists of about 15% pharmacy practice standards and 85% pharmacy law. It tests for competency in hospital, community, and ambulatory care pharmacy.
 - 3. The MPJE is a combination of state and federal law with no practice standards included. In recent test results, the MPJE has had a higher pass rate than the CPJE.
 - 4. The Board of Pharmacy does not have the authority to make this change. It is solely up to the California Legislature. Any legislative change will take at least one year to implement.
 - 5. The deans of the more recently established Schools of Pharmacy in California are concerned about a low pass rate of their school's graduates on the CPJE. The deans fear this may affect their school's application for accreditation by the ACPE (Accreditation Council for Pharmacy Education). Residency directors are concerned because their residents from out of state are having trouble passing the CPJE.
 - 6. At this time, there is a surplus of pharmacists in California and the job market is saturated.
 - 7. The current California Society of Health-System Pharmacists (CSHP) Professional Policy endorses retaining the CPJE and NAPLEX as requirements for licensure.
 - 8. An informal poll of CSHP affiliate chapter presidents by Keith Yoshizuka found a
