# Tech Liaison (Jeff)

- Jeff is currently the liaison between DSHP and the PTEL chair, Jeff has been
  active in DSHP in years past and we welcome him back to our board meetings.
  Jeff has been active in pharmacy since 1997 and working for Kaiser Permanente
  Northern California for 20 years.
- The current goal of the CSHP liaisons is to increase tech membership with an eventual goal of 150 technician members; the goal for this year is to get an additional 35 technicians to join and this is outlined in their SMAP.
- Outreach to pharmacy technician schools will be a key component of their plan
- Advocating for the Advance Pharmacy Technician (APT) certification is another goal. APT certification will include expanded non-discretionary tasks, technology certification and vaccine administration for technicians. Listening sessions around this have been held and the BOP had a licensing committee meeting today (4/19) to review the input from those sessions. The BOP's next public meeting will be 7/18 and is another opportunity to voice support for APT. Legislation may come as early as February 2023. Johnny Wong recommended more advance notification of listening sessions and other meetings around this topic as it is hard for practitioners to make events on short notice.
